THE PLAN APPROVED BY THE BOARD OF DIRECTORS INCLUDED A THREE-YEAR STRATEGY TO BRING POSITIONS UP TO "AVERAGE" COMPENSATION BASED ON OTHER NONPROFIT ORGANIZATIONS IN MARICOPA COUNTY. THAT INCLUDED THE EXECUTIVE DIRECTOR POSITION WHICH WAS COMPENSATED AT LESS THAN THE AVERAGE. THE BOARD KEPT POSITIONS AT THE SAME COMPENSATION IF THEIR SALARIES WERE HIGHER THAN THE AVERAGE FOR OTHER NONPROFITS IN MARICOPA COUNTY OF SIMILAR SIZE. IN NO CASE WAS THAT COMPENSATION HIGHER BY MORE THAN A 10% VARIATION FROM AVERAGE.

IN 2009, THE BOARD APPROVED FURLOUGH DAYS WHICH ACT TO REDUCE THE WORKING HOURS AND COMPENSATION OF ALL DUET EMPLOYEES BY TEN PERCENT. THE BOARD WILL REVIEW ITS COMPENSATION STRATEGY OF MARKET EQUALIZATION AGAIN WHEN FINANCIAL CONDITIONS ALLOW.
