IN 2015 VOLUNTEERS FROM NEARLY 200 PARTICIPATING CONGREGATIONS AND THE COMMUNITY WERE PAIRED WITH 757 HOMEBOUND OR DISABLED ADULTS WHO PROVIDED 7,404 ESCORTED TRANSPORTATION RIDES, AS WELL AS OVER 46,566 HOURS OF SHOPPING, BUSINESS HELP, FRIENDLY VISITING, FRIENDLY PHONING, ASSISTANCE IN WRITING LIFE STORIES, COMPUTER TRAINING, RESPITE ASSISTANCE, TRANSPORTATION, AND/OR HOME REPAIRS.

FIVE SUPPORT GROUPS HELPED 284 ATTENDEES. 37 UNDUPLICATED GRANDPARENTS AND 59 UNDUPLICATED GRANDCHILDREN BENEFITED FROM 1,173 DAYS OF RESPITE, AND LEGAL ASSISTANCE HELPED 39 GRANDPARENTS GAIN FORMAL CUSTODY OF THEIR GRANDCHILDREN.
